You may choose not to participate at all, may refuse to participate in certain procedures or answer certain questions, or may discontinue your participation at any time without penalty. Your decision to participate will not affect your relationship with any local, state, or Federal organizations, or the person who identified you as a potential participant. MODERATOR: SESSION INTRODUCTION SCRIPT

Thank you for agreeing to participate. Today, we'd like to get your feedback about Washington State's Voter Registration Form. We're trying to understand how well the form design works for people like you.

For the next few minutes, I'd like you to pretend you're registering to vote. We'll watch you doing that. We will be taking notes while you register.

When you have finished, I'll ask you to fill out a brief questionnaire. Then I'll ask you some questions about what you thought of the form and what the experience of using it was like. The whole interview should take about 15 minutes.

Please remember that you are not being tested in any way. Your taking part in the study helps us evaluate how well the form works. Do you have any questions at this point?

Lets get started.

Although this situation will be similar to registering to vote because you have a form that looks real, you're not really registering. By completing the task as you normally would on this form, you're helping us learn where people like you might have questions or problems with using it.

This form will not register you to vote.

This is the form I would like you to use.

Are you ready to register? Please try to do what you would normally do, not what you think I want you to do. If you're undecided about a question or section, do what you would do if you were really filling it out.

From this point on, you should treat me like a frontline staffperson.

If you have questions or problems with the form, ask me. I'll note your question and if it's appropriate, I will help you. Let me know when you have finished.

MODERATOR: SESSION INTRODUCTION SCRIPT (CONT'D)

*[While the participant is filling out the form, observe them without disturbing them.
Don't teach them how to use the form!]*

[When they have finished, give them the post-study questionnaire.]

Please answer this questionnaire. When you are finished I will ask you a few questions.

MODERATOR: POST-STUDY QUESTIONS

Washington State Voter Registration Form Usability Study, July 2009

1. Please step me through what you did on the form. Let's just go through it from where you started and tell me about any questions, doubts, or confusion you remember having along the way.

Ask participants follow-up questions based on behavior they exhibited, hesitations, or the questionnaire (any "strongly disagree" answers).

Try to keep questions open-ended. For example, if the participant missed a section or didn't fill out the form according to your instructions, go to that place in the form and say, "Tell me more about what you did on the form here and why."

or

"I see you said that you strongly disagree that you feel confident using this form. Tell me about that."

2. How is the type size for you?
3. Is there a particular place on the page your eye was drawn to when the form was given to you?
4. How did using this form compare with other forms you've filled out, even the current registration form if you are registered and remember using it to register to vote?
5. What help do you think that other people might need in using this form?

The purpose of this evaluation was to get your feedback on the effectiveness and usability of the Washington State Voter Registration Form.
